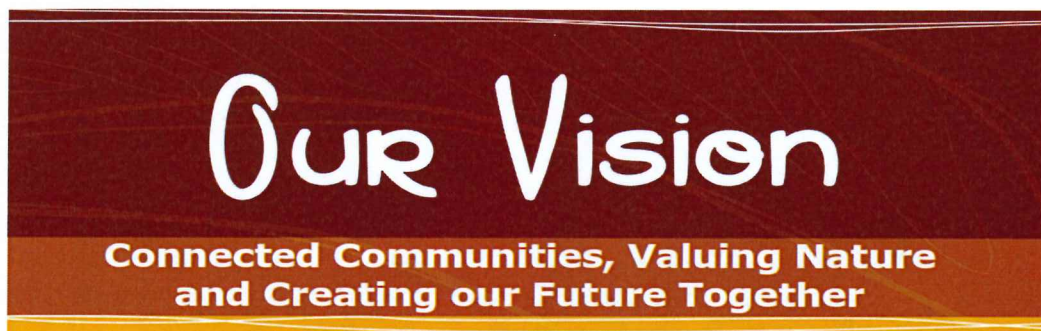

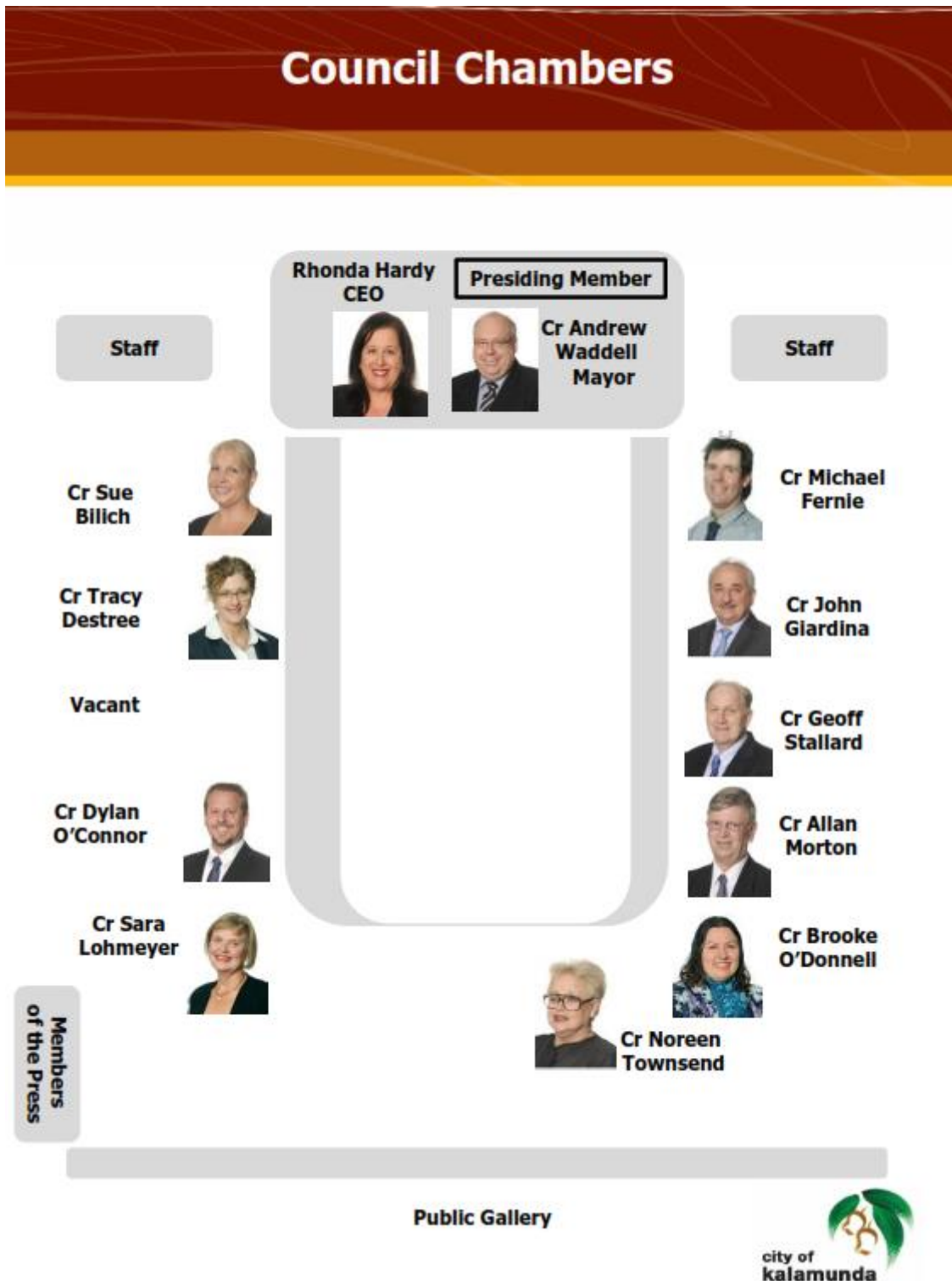


INFORMATION FOR THE PUBLIC ATTENDING COUNCIL MEETINGS
