# Disability and Carers Advisory Group Monday 12 August 2024 Function Room, Administration Building

# 1.0 Official Opening:

We wish to acknowledge the traditional custodians of the land we are meeting on, the Whadjuk Noongar people. We wish to acknowledge their Elders past, present and future and respect their continuing culture and the contribution they make to the life of this City and this region.

1.1 The Presiding Person opened the meeting at 3:32 pm.

# 2.0 Presentation by Asset Planning & Delivery, City of Kalamunda

Shaphal Subedi, Coordinator Asset Management (CAM) and Rory Smith, Coordinator Design & Survey (CDS) gave an overview of the City's Pathway Program.

Simon Lee, Traffic Engineer, City of Kalamunda, attended as an Observer.

The City has 3 types of pathway programs:

- Pathway Renewal for existing footpaths as per the Pathway Asset Management
- Pathway Handover gifted from the developers of subdivisions.
- New pathways as per the New Path Policy 2018. New footpaths have been identified for future works.

The City has 389kms of pathways in the City. Pathways are rated according to their condition and assessed every 5 years. Rating of 1 means the path is in very good condition and rating of 5 being of very poor condition.

If a request for a new footpath meets the minimum requirements as per the City's internal path decision process, it is then scored using the City's internal paths scoring matrix. The matrix assesses traffic volumes, vehicle speeds, access to existing infrastructure, amongst other things. Scores achieving between 31 – 50 are assessed as high priority, added to the 15-year long term financial plan and then is proceeded through for budget considerations.

Once a new footpath has been approved it gets handed over to the City's Coordinator Design & Survey (CDS). Currently the City's pathway network satisfies the minimum Australian standard of 1.2 metres, however the City's best practice is for between 1.5m (to allow for a wheelchair and pram) and up to 1.8m (to allow for 2 wheelchairs).

Yvonne Huntley (YH) mentioned there are many footpaths within the City of Kalamunda that do not have tactiles, making it very difficult to navigate safely whilst walking to the Kalamunda CBD. CDS replied that all new footpaths and major renewals in the future will include visual cues and tactiles at crossroads.

YH mentioned that the speed limit throughout the CBD area needs to be 40km/hr. CDS replied that main roads control the speed limit and for the City to submit a request to main roads, the City must show that it has made efforts to slow traffic down by installing traffic calming devices first. A section along Railway Rd between the Mead St/Mundaring Rd roundabout to just after the old Thai on the Hill is already 40km/hr.

YH asked about the progression of Jorgenson Park accessible walk trail. CDS replied there has been \$10,000 allocated in the budget this year for concept design. YH asked to be consulted with each step of the way. CDS will liaise with YH through the CDO-IC.

#### 7.0 Members Interest Areas:

As identified in the May Meeting discussion, each advisory group member was asked to consider their 'reason for being' a member of the group. The following updates are progress the City has made since the last meeting in relation to those specific areas.

#### 7.1 Access Improvements:

- a) Hidden Disabilities Sunflower Program. CDO-IC put forward a proposal for the City of Kalamunda to become a Sunflower Friendly Place, to support people with invisible disabilities.
  - In Australia, 1 in 5 people have some form of disability.
  - Roughly 80-85% have a disability that is non-visible.
  - There are hundreds of hidden disabilities ranging from autism spectrum disorder, dementia, brain injuries, mental health, intellectual disabilities, vision and hearing impairment, chronic illnesses and many others.
  - The Hidden Disabilities Sunflower is a simple tool for people to voluntarily share that they have a disability or condition that may not be immediately apparent – and that they may need a helping hand, understanding, or more time in shops, at work, on transport, or in public spaces.
  - As a business member of the global Hidden Disabilities Sunflower network, the City can positively impact society so individuals with a hidden disability can fully participate in the workplace and in the community.
  - For the City of Kalamunda to become a standard member it will cost \$500 per annum which allows the City to tap into solutions to show support of customers and any staff members living with hidden disabilities. By becoming a member, the City will benefit from access to tailored inspiration & inclusion tips, member discounts and ongoing staff Sunflower training and webinars and a 7-minute training video. A free sunflower starter pack is included in the membership.
  - Additional merchandise can be purchased at a cost. Minimum cost outlay would be \$570 to get 100 sunflower supporter lanyards.
  - Total cost with lanyards and membership will be \$1070. CDO-IC total access budget is \$1800.

- To install one Chat with me Board last financial year cost \$1284, which the CDO-IC split over 2 financial years for both boards.
- The group were asked on their thoughts on the City becoming a member.
- BB said if the City was to become involved then the City will need to be mindful that limited training is provided from Hidden Sunflowers and the City will need to invest in more training, to ensure it is more than a tokenistic gesture.
- GN said it is a good initiative and a lot of the students at Kalamunda Secondary Education Support Centre have lanyards already.
- The advisory group was undecided on whether to become a member or not and requested more time to decide.

- *b)* The City of Kalamunda's Accessible and Inclusive Business Guide has been distributed to members of Kalamunda Chamber of Commerce.
- c) The City is commencing a monthly promotion of the Footpath Awareness Campaign and the Gopher Charging Stations on the City's Facebook page, starting August 2024.
- *d)* Refer to correspondence register for other access improvements.

#### 7.2 Linking people with a disability into community:

- a) Members of the Youth Action Kalamunda (YAK) at Kalamunda Secondary Education Support Centre are creating artwork that expresses their personal interpretations of gratitude towards their carers. These pieces will be showcased in an art exhibition at Kalamunda Central during Carers Week 2024. Discussions with Kalamunda Central and the Coffee Club are scheduled to finalize the event details.
- b) KSESC Kalability Catering has been involved in the City of Kalamunda and Lesmurdie Senior High School Intergenerational Storytelling Project with the crew providing morning tea at the launch and at the final session on 19 September.

# 7.3 Early Childhood and Youth access and inclusion:

*a)* Magnolia Reserve All Abilities Playground Official Opening scheduled for 29 August 3:15pm to 4:30pm, date to be confirmed.

b) The City of Kalamunda has been successful in receiving a \$60,000 grant to improve support and development for 0-5s, based on the Australian Early Development Census. Applications currently open for a Project Officer.

In May 2024 the City requested a Building Application be submitted as well as a AS1428.1 compliant plan. The City also made comment the plan suggests that the swing of the door will impact on those exiting the building may need an electronic opening with a delayed closing.
