8.2 **Footpath Renewals:**

YH emailed stating that most of the footpaths in Kalamunda need attention.

CDO-IC informed the group that the City has a 15-year capital works plan for upgrades to footpaths. The condition rating of the footpath is conducted every five years. The condition rating is for adding projects to the Long-term financial plan (LTFP).

This financial year, Asset Management are conducting the footpath condition inspection. If the condition inspection identifies the projects for an LTFP, they prepare the budget bid and add projects for the 15 years capex program.

8.3 Update on Jorgensen Park Accessibility Path:

YH requested an update on the accessibility walk trail path at Jorgensen Park.

CDO-IC advised the group that the project did not get municipal funding for 23/24. Coordinator Asset Management has added the project for design 24/25 and construction 25/26.

PC enquired if grant opportunities could be investigated in the future.

9.1 Carers Week October 2023

To celebrate Carers Week, the City, in partnership with Kalamunda Kalability and Building Friendships held a Carers Morning Tea for unpaid Carers in the community to thank them for all their hard work and dedication. The students from Kalamunda Secondary Education Support Centre provided a delicious high tea whilst the Carers enjoyed making flowers to place on the Carers mural.

9.2 International Day Of People with Disability November 2023

The City received funding from International Day of People with Disability (WA) to hold a Community Art Mural based around the theme My Life; Our Community. Artist Eleisha Pirouet was engaged to co-ordinate the workshop and worked with a person with a disability to co-design the mural and help facilitate the painting. Over 40 community members came along to paint the community-designed mural.

9.3 Kalamunda Compassionate Communities

The City of Kalamunda was awarded as the Winner of the Outstanding Local Government Supporting a Compassionate Community Award. The awards acknowledge the efforts of those professionals and volunteers who care for people who are at end-of-life and offer public recognition of individuals, teams and organisations who provide holistic and compassionate support and care in all settings across WA.

The City of Kalamunda takes immense pride in the project's remarkable achievements with the Compassionate Communities Project and the positive impact it has had on our community has been truly heartwarming.

There is now a working group that has been formed amongst community members, with the next meeting being held on Saturday 24 February at 2pm at KCC. Planning is underway for the first event, Lantern Memorial Floating Lantern event at Stirk Park.

9.4 Stirk Park

A Chat with Me Communication Board has been installed at Stirk Park in the junior section. Communication boards are devices used to support people who need help expressing themselves. People can use the symbols to make choices, share ideas and direct action during play. Another fantastic example of the City's continuous commitment to welcome all abilities and champion inclusion.

Gopher Charging Stations

The City is pleased to advise that community members who use an electric mobility device are now able to recharge their device for free at the Hartfield Park Recreation Centre and Kalamunda Library. Following on from the successful Keeping Footpaths Clear awareness campaign, this is another example of how the City is continually looking for ways to improve accessibility and inclusivity for all.

PC stated it would be great if the City could look at purchasing chargers for both facilities.
