8 AGENCY UPDATE

8.1 DEPARMENT OF FIRE AND EMERGENCY SERVICES

- 8.1.1 It's been a normal summer with few incidents. Local crews deployed to the Cyclone in the North of WA, fortunately there was not a lot of devastation.
- 8.1.2 Mike Hall was deployed to the recent fires in Victoria for a week. We have had nothing in the local area.

8.2 DEPARTMENT OF COMMUNITIES

- 8.2.1 I have sent through the quarterly report, high threat season with preparedness exercises hoping to assess the norther suburbs.
- 8.2.2 Department of Communities has also reviewed local support services such as accommodation.
- 8.2.3 We will be recommencing evacuation centre training and we are championing application for Disaster Relief Funding.
- 8.2.4 Department of Communities have been activated 11 times this season. We had a lot of staff deployed for the cyclone in the North of the state.
- 8.2.5 The State Support Plan was approved. The main change was Level 1 incidents now qualify for accommodation. Those eligible will be provided up to 3 days housing. The type of questions the department ask community, (Do you have friends and family? Do you have insurance? Is the home owned by Department of Communities?).
- 8.2.6 Danielle Clark is the new Metropolitan Regional Officer and has taken over from Naomi Jory.

8.3 KAL - COORDINATOR ICT OPERATIONS

8.3.1 Business as usual, it is good to hear that Cyber Security will be recognised as a hazard with the State Government.



8.3.2 The City is currently undergoing the process of obtaining new cyber security. This is currently with the tender process.

8.4 PERTH AIRPORT NP

- 8.4.1 Perth Airport has been busy in the aviation space, we had the incident which occurred on Rottnest Island. We would like to make everyone aware that the report for this is available on the ATSB (Australian Transport Safety Bureau) website.
- 8.4.2 The Delta Fire Incident occurred and there was a massive response to that. Perth Airport has been picking up all the findings and trying to learn from the experience.
- 8.4.3 November 2024, Perth Airport conducted a full-scale plane crash exercise. The plane had crashed and wasn't initially on fire, then turned into a fire. We have a report on the exercise which is lengthy compared to the last exercise in November 2022. We are working towards fixing the issues from the exercise and it will be summarised in the annual report.

8.5 KALAMUNDA VOLUNTEER BUSHFIRE BRIGADE

8.5.1 There has been nothing significant, usual run of traffic accidents, property fires and arson. There was a deliberate fire lit on Silverdale Road, potentially by children. Thankfully, nothing significant occurring in these incidents.

8.6 LESMURDIE SENIOR HIGH SCHOOL

- 8.6.1 Smooth start to the year. The hot weather policy has been activated one week out of the four so far. We also conducted our first fire drill for the year which encompassed our near year 7's. They did well.
- 8.6.2 The Hot weather policy consists of all students are not allowed out on the oval or the basketball courts. Students are required to come into collegiate spaces with air conditioning such as libraries.

8.7 KALAMUNDA SENIOR HIGH SCHOOL

- 8.7.1 Kalamunda has been the same for the heatwave. The school has identified a new app, the Physical Education department found it. The App is called SMA Extreme Heat Policy. The app links BOM, Location and Activity, risk rating and things to do to mitigate the risk while exercising outside. We have been using this proactively with parents, who has been happy with the information SMA Extreme Heat Policy.
- 8.7.2 We had a meeting with the Bibbulmun Network Principals. That was reinforced by the Coordinator of Regional Officers, it has been the smoothest start to the year in 8 or 9 years in the education space.
- 8.7.3 We have Department of Fire and Emergency Services coming out for our routine bushfire inspection.
- 8.7.4 Our new building is still being built. The builders are thinking they will be



- finished by the end of Term 1. The school will not be moving into the building until Term 3.
- 8.7.5 We had occupancy just as we returned to school in the new year in our new Visual Art Block at the beginning of the year.
- 8.7.6 Low cohort numbers in primary schools. We up in the Senior School. This is not from intake but just seems to be across the other years with about 40 new enrolments.

8.8 KALAMUNDA HOSPITAL

- 8.8.1 Kalamunda Hospital is updating all its Emergency Action Plans. We have had a massive clean-up. We are overdue for our inspection through the brigade for our drill.

8.11.1 We have had a quiet summer. Red Cross has a new initiative in Community Disaster Resilience. Working disaster resilience with Cultural Communities, First Nations People, LGBTQI+. That program is going together now.

8.12.1 The Poly Shot Hole Borer has increased; we have started to see an increase in the location. We have seen infestations in the range of 20-50 trees.
