**Request to Expand Scope of the 'Tonkin Highway Corridor – Roe Highway to Kelvin Road' Project**

On behalf of the City of Kalamunda, I write to raise concerns regarding the scope of the current Tonkin Highway Corridor - Roe Highway to Kelvin Road project, and to formally request that it be expanded and funded to include construction of a dual-lane roundabout at the intersection of Lewis Road and Welshpool Road East.

The City has determined that the grade separation works planned at Tonkin Highway intersections with Welshpool Road East and Hale Road will have a severe and detrimental impact on the surrounding road network and local road users, both during the construction phase and in the long term. A key area of concern is the intersection of Lewis Road and Welshpool Road East, which is expected to experience increased pressure as a result of the Tonkin Highway upgrades, compounding existing safety and traffic issues.

To address these concerns, the City requests that the scope of works be expanded to include the roundabout at Lewis Road and Welshpool Road East, which would:

- a) Improve the safety of vehicles entering and exiting Lewis Road
- b) Improve the safety of vehicles travelling along Welshpool Road East
- c) Enhance traffic flow and reduce queuing during peak periods
- d) Enable safe U-turn movements from all directions
- e) Incorporate an interconnected Principal Shared Path (PSP) for cyclists and pedestrians

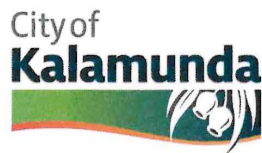

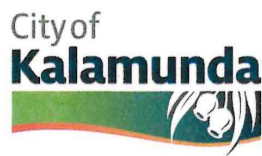
