## Executive Summary

### Dog Exercise Area Management Plan 2023 (phase 2)

The City of Kalamunda is developing its Dog Exercise Area Management Plan to guide the City's approach to promoting responsible dog ownership and management of dog exercise areas throughout the City. The plan will outline the designated off-leash dog exercise areas, fenced dog exercise areas and dog prohibited areas and strategies to promote responsible dog ownership including signage and enforcement.

In April 2021, the City of Kalamunda Dog Local Law was Gazetted. In preparing the draft Dog Exercise Area Management Plan, the City commenced community engagement in September 2021 to understand their aspirations and needs for dog exercise areas in the City. The 2021 survey received 342 responses and was widely advertised via an integrated marketing communications campaign promoted via online, print and outdoor mediums.

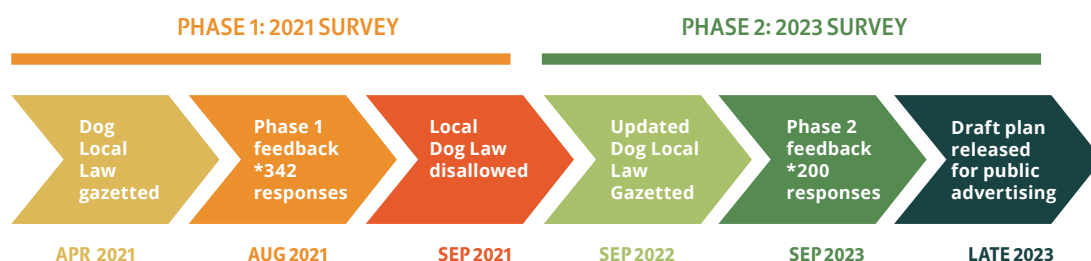
In September 2021, the Joint Standing Committee on Delegated Legislation finalised their review of the Dog Local Law and found it be invalid, concerning changes made after the public advertising process. The City recommenced the Dog Local Law process and the development of the draft Dog Exercise Area Management plan was temporarily put on hold while the local law was finalised.

The updated Dog Local Law was Gazetted in September 2022. With a significant period of time lapsing between the 2021 feedback, the City opted to seek public comment on the outcomes from the 2021 community engagement, to identify if community sentiment was still the same or if it has changed (Phase 2).

Phase 2 community consultation ran from 8 September, to 9 October 2023 and was delivered via a comprehensive Communications and Engagement Plan and progressed to IAP2 spectrum level 'consult' to 'obtain public feedback to ensure that they are informed (of the phase 1 findings) and listen to their concerns and aspirations.

The engagement attracted 202 survey responses from the community and one (1) written submission. Similar to the 2021 survey, responsible dog ownership emerged as a key theme across the eight (8) questions. There were some shifts in sentiment, particularly with the 'quality rating' of dog exercise areas, with 37% being 'happy' in 2021, compared to 28% in 2023.

## Communication

Communications activities were targeted towards respondents to the 2021 survey, as well as the general community.

- **EDM (electronic direct mail):** to participants on the engage.kalamunda portal who responded to the 2021 survey and the Dog Local Law public advertising periods.
- **Print Ad:** in the Echo Newspaper on Friday 8 September 2023.
- **Engage portal:** Project page on engage.kalamunda.wa.gov.au, supported by direct links to dog-related City content and supporting agencies.
- **Social media:** four (4) posts over four (4) weeks, garnering 22,025 total impressions and an average engagement rate of 11%.
- **Print distribution:** A4 survey and flyers distributed to all City centres.

## Engagement Outcome

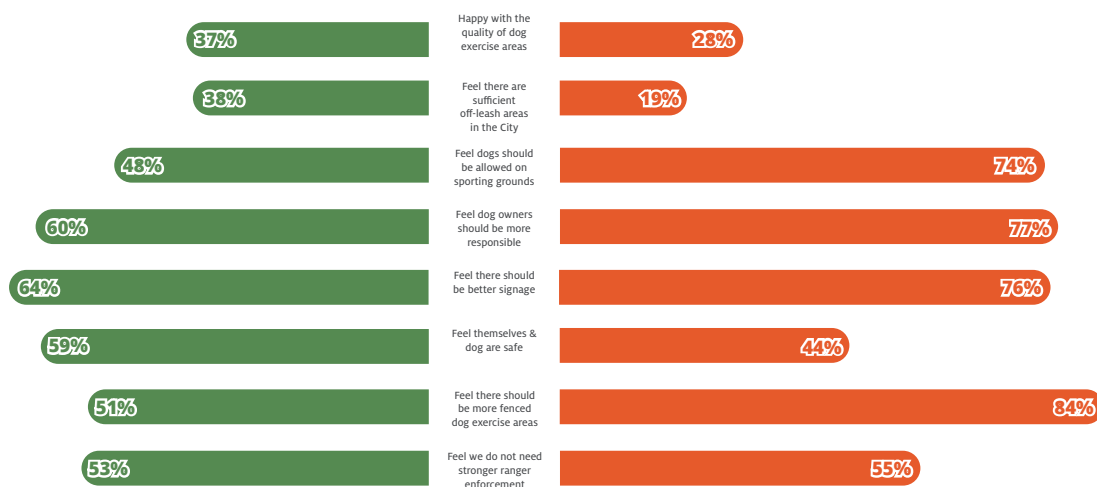
The 2023 survey received 203 survey responses and one (1) written submission. The purpose of the 2023 survey was to identify if there have been any major shifts in the community's needs and aspirations for dog exercise areas in the City.

### Sentiment

Community sentiment centered around a desire for dog owners to be responsible with their dogs off-leash, as well as cleaning up after their dogs in public places.

There were some shifts in sentiment, particularly with the 'quality rating' of dog exercise areas, with 37% being 'happy' in 2021, compared to 28% in 2023. The biggest shift was for dogs being allowed on sporting grounds, increasing from 48% in 2021 to 74% in 2023, and 84% felt the City needs more fenced dog areas, compared to only 51% in 2021.

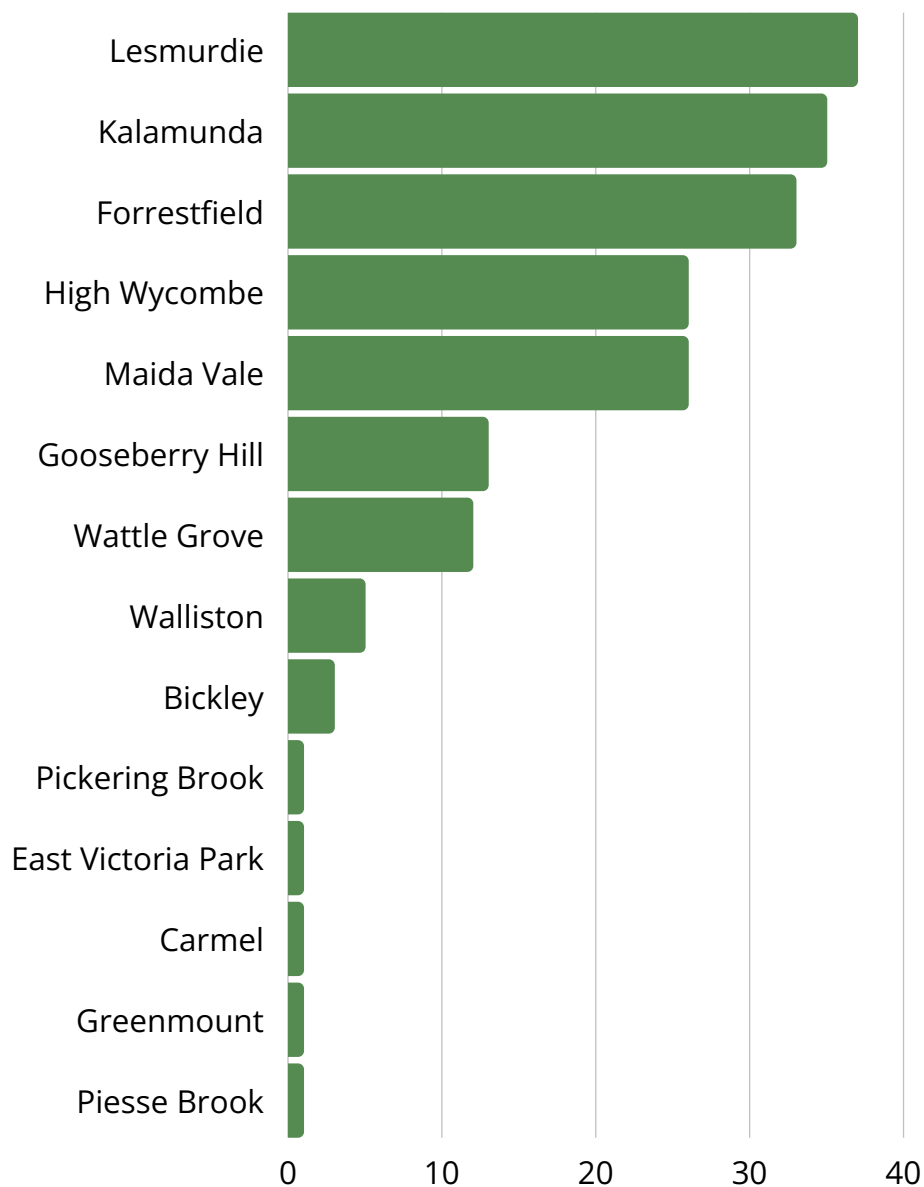

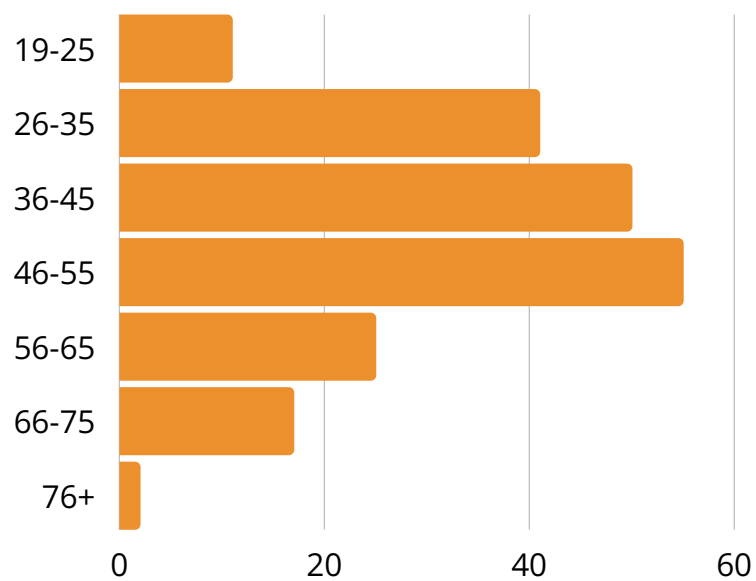

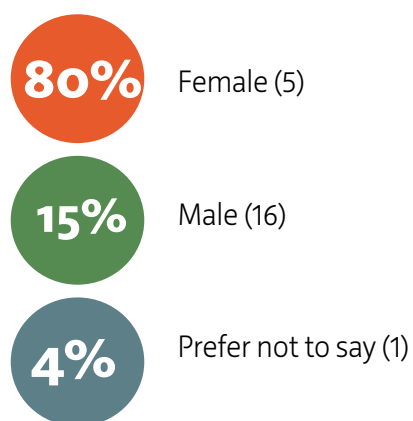
### Suburb of respondents



### Age of respondents

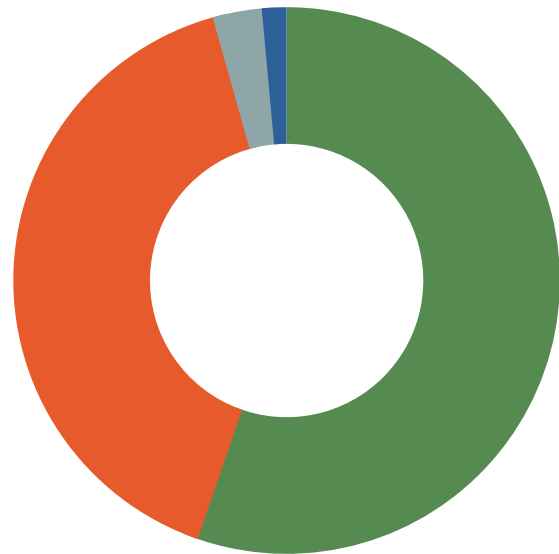
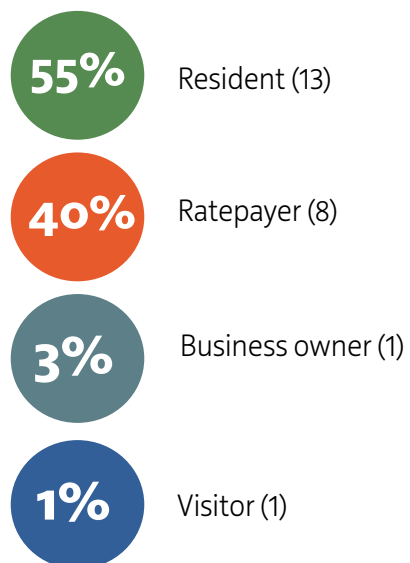


### Gender of respondents

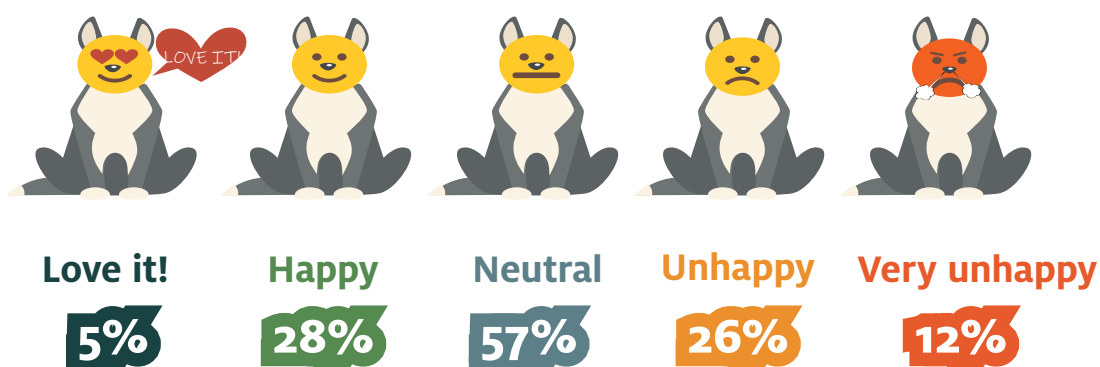

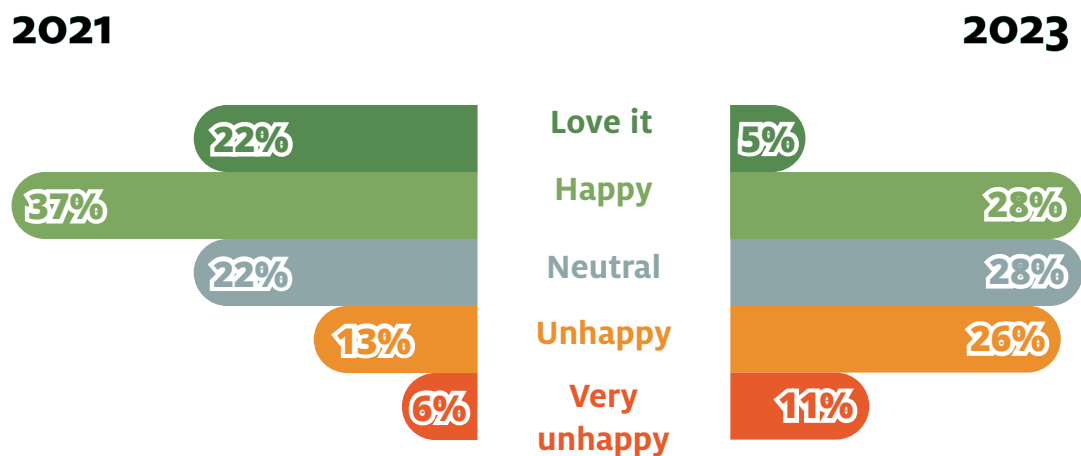

## Comparison of 2021 responses to 2023

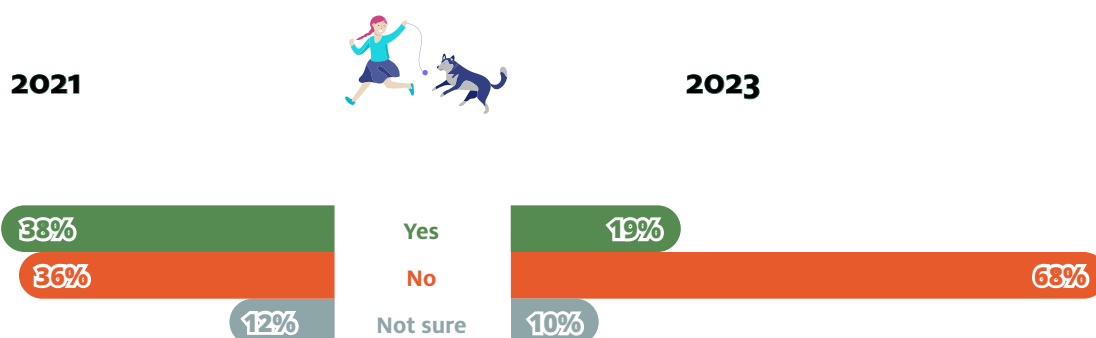


## Analysis

Compared to 2021, sentiment towards the quality off-leash, unfenced dog exercise saw shifted away from mostly positive and neutral towards negative. The biggest shift was the rating of 'Love it' dropping to 5% in 2023, compared to 22% in 2021. The rating for 'unhappy' increased from 13% in 2021 to 26% in 2023 and 'very unhappy' increased to 11% in 2023 compared to 6% in 2021. Neutral had the smallest shift, being 28% in 2023 compared to 22% in 2021.

## Engage (Survey) | Responses

## Question 2: Are there sufficient off-leash dog exercise areas within the City of Kalamunda?



### Sentiment

In 2023 68% of respondents felt that the City does not have sufficient off-leash dog exercise areas, which is a big increase from 36% in 2021. The key theme from responses were that there were not enough dog exercise areas throughout the City, in particular the suburbs of Kalamunda, Lesmurdie, Gooseberry Hill, Wattle Grove and Maida Vale being mentioned. Comments mentioned that most parks required travelling by car.

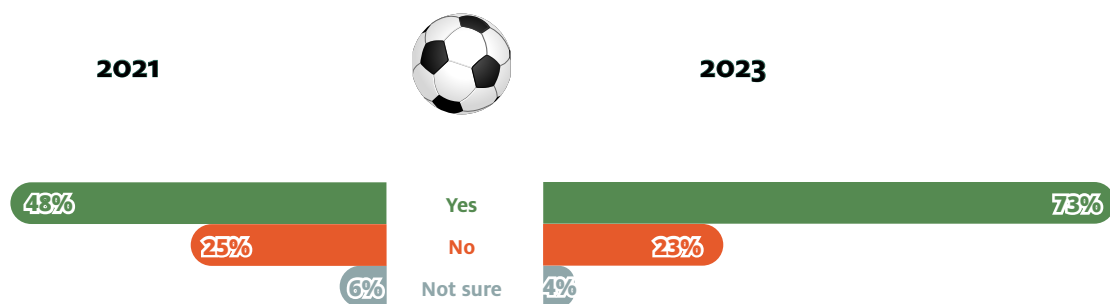
"I regularly use Elmore dog park - I love that there are separate fenced areas for small and large dogs. PLEASE can we get something like this in the kalamunda/lesmurdie area?!! Flora Terrace reserve might be a suitable area. Jorgeson Park does not suit us as there are too many big dogs that run up on our little ones and scare them".

In Kalamunda/Lesmurdie there are no fenced areas to exercise dogs

"Majority of parks/open spaces are on-leash in High Wycombe".

## Engage (Survey) | Responses

### Question 3: Should dogs be allowed on sporting grounds if there is no scheduled sport taking place?



### Sentiment

In 2023, 73% of respondents felt that the City should allow dogs on sporting grounds if there is no scheduled sport taking place. This saw a significant shift from only 48% who agreed with this statement in 2021. The ability to access more areas for walking dogs was cited as important, with respondents acknowledging that most nature reserves/open areas are restricted to dogs. However having owners clean up after their dogs emerged strong, with 31 respondents listing this as important.

- More options for dog owners
- Cleaning up after dogs

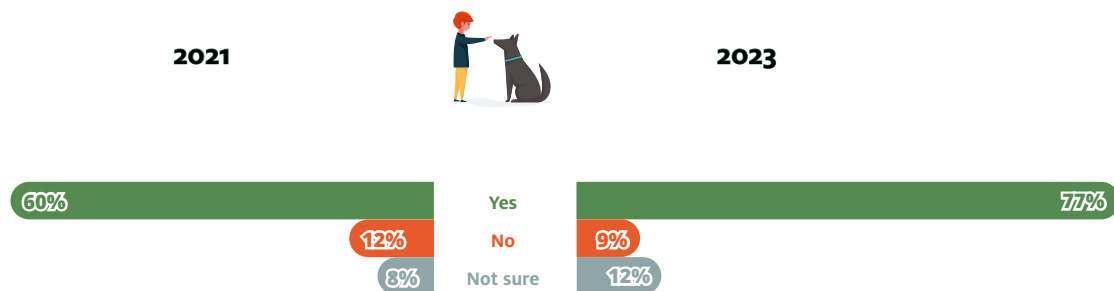
"Sporting grounds are for just that. Plenty of non-sporting ground areas that could be made dog off lead areas to improve availability of off lead dog areas".

"wide open space where you could run with your dog, but dog owners MUST pick up the poo or be fined".

"The dual use would be perfect, given a lot of the places my dogs can't go due to National Parks, it's actually quite limiting".

As long as dog owners clean up after themselves, I don't see why not.

## Question 4: Should there be more responsibility by dog owners?



### Sentiment

In 2023 sentiment towards dog owner responsibility remained steady, with 77% agreeing that dog owners should be more responsible. Dog owners not cleaning up after their dog emerged as a key theme, followed by owners ignoring rules or signs (i.e. allowing dogs off-lead in all areas). Dogs that are aggressive or have poor socialisation, as well as poor recall/obedience (i.e. does not return when called) was cited as another issue for most dog owners. On the other end of the spectrum some respondents felt that most dog owners are responsible, with the exception for a small minority who are not.

- Cleaning up after dogs
- Ignoring rules
- Aggression/poor socialisation
- Recall/obedience
- Unfair perception of dogs

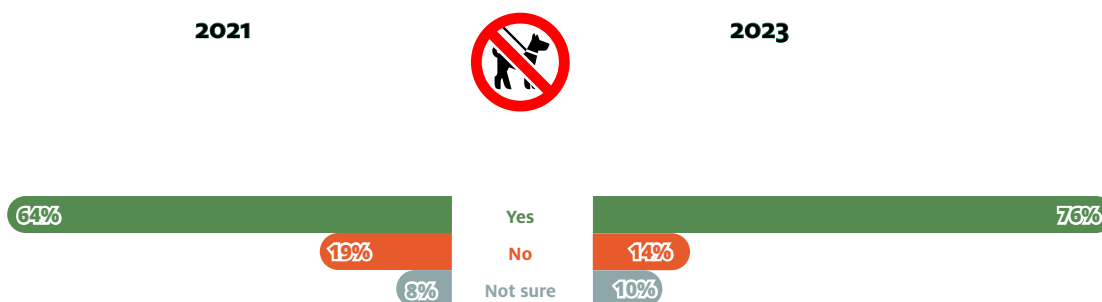
"Off-leash dog area still need basic recall on their dogs. It's not a free for all and owners are dismissive when their dogs are aggressive or show anti-social behaviour".

"Too many are irresponsible- but more are responsible and do the right thing".

"Very frustrating to see signs indicating no dogs permitted, or dogs on lesh, yet owners ignore, or don't see signs".

"Picking up poo is a big thing. I see it everywhere when walking my dog or taking him to exercise areas".

## Question 5: Should there be better signs or information regarding the different zone's rules and regulations that apply to dog owners?



### Sentiment

In 2023 sentiment towards having better signage or information remained steady, with 76% agreeing with this statement compared to 64% in 2021. Most respondents felt that having better signage would provide clarity, but should also be simple and easy to understand. Emerging issues also included dog owners allowing their dogs to be off-leash in on-lead areas, as well as dog owners not cleaning up after their dogs. Some respondents felt that more signage would be a waste of time, as some dog owners will ignore the signs anyway.

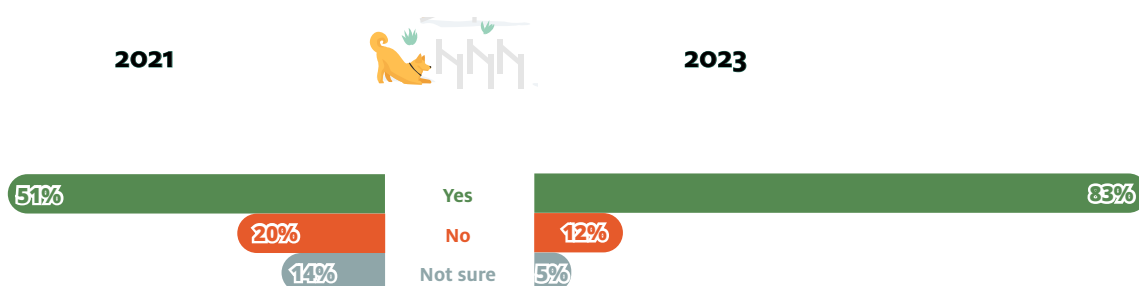

"Clear, simple signage as opposed to a long list of rules may be more effective. Or perhaps in addition to the set of rules signage in dog areas about picking up poo".

"Off-leash does not mean no rules. More signs stating rules of off-leash areas. Owners need to have control over their dogs".

"Too many dog owners do not take responsibility for cleaning up after their dogs. Whether at Jorgensen Park or on street verges; it's appalling. Please place obvious signage stating that fines are applicable".

## Question 6: Should there be more fenced dog exercise areas?



### Sentiment

In 2023 there was a big shift towards this statement (similar to the question if there are sufficient dog exercise areas) with 83% agreeing the City needs more fenced dog exercise areas, compared to 51% in 2021. Respondents felt that the City needed more, particularly in the suburbs of Kalamunda and Lesmurdie and would provide more equitable access for residents, particularly the elderly who may not be able to travel. Safety emerged as another key theme, fenced areas helping to keep the dogs and public safe (i.e. dogs cannot run up to children or run onto roads). Some respondents suggested having fenced off-leash areas and the benefits of socialisation and exercise were also mentioned.

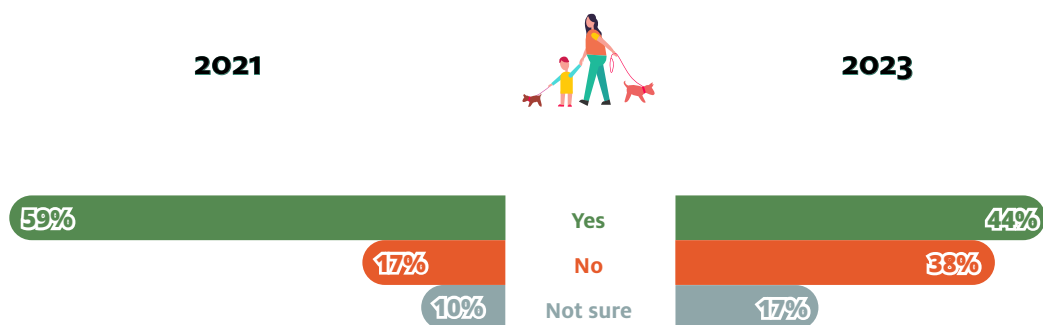

"There are none in our suburbs. Older people do not like to drive down & up the hill".

"Many reasons really. We have the space up in the hills to provide these areas, people coming up here from other suburbs over Perth which means more dogs. Keep dogs, owners and kids safe by not having too many dogs in one place and leading to potential dog fights or kids being injured etc".

"Yes- it provides a safer area for the dogs - meaning they can't run into children or on roads".

## Question 7: Do you and your dog feel safe in the City's off-leash or fenced areas?



### Sentiment

In 2023 there was a big increase in respondents who did not feel safe in the City's off-leash or fenced areas from 17% in 2021 up to 38% in 2023. However 44% of respondents in 2023 did feel safe, a small decrease from 59% in 2021. Poor recall (i.e. not responding to owners when called) emerged as a key factor contributing to dog owners not feeling safe, followed by aggression and socialisation. The need for better fencing emerged as another key issue, as well as the need for double gates, as some dogs are still able to escape fenced exercise areas. Separation of smaller/larger dogs and vandalism/ignoring rules were also mentioned.

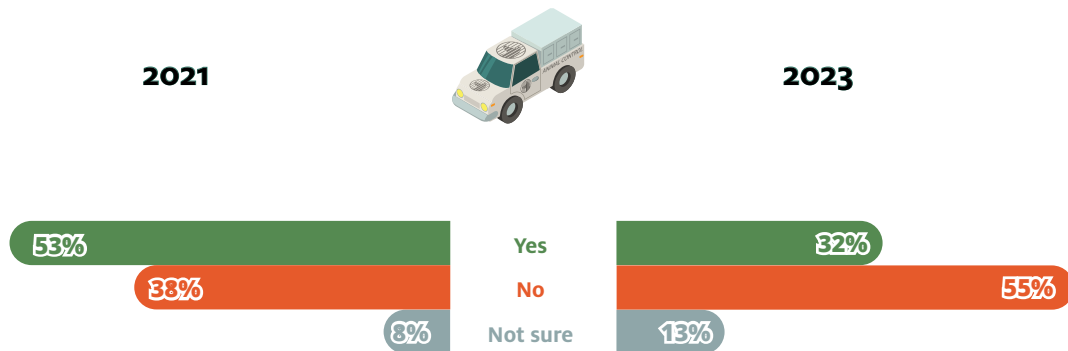

"Not all pet owners are responsible and dog fights have taken place".

"No double gates. So dogs escape when new playmates arrive and open the gate".

"There is a very small number of 'repeat offenders' that walk their dogs off leash knowing they might be a risk to others. Others who think their dogs' rough & loud 'play' which can set off other dogs in defence, is not their issue".

## Question 8: Is stronger enforcement or Ranger presence required?



### Sentiment

In 2023 there was a big shift away from Ranger presence being required, with 55% responding 'no' in 2023, compared to 38% in 2021. Respondents felt that having Rangers more 'visible' and 'contactable' would be beneficial, while others felt Rangers could be present to educate and inform dog owners, rather than enforce. Some respondents felt that increased Ranger presence would not make a difference, while some unfortunately had a negative experience/perception of Rangers.

- Visibility/contactable

"it can be difficult to get hold of a ranger (for dog problems or other things) on weekends".

"The Rangers have other important tasks to undertake. There needs to be a big push by local government to get dog owners up to speed on the responsibilities of owning a dog, training a dog, handling a dog and exercising a dog".

"could possibly be more contactable after office hours and weekends".



## Any other comments?

"There is NO fenced dog area in the Kalamunda/Lesmurdie area. This needs to be improved. Alan Anderson Reserve would be perfect. Anywhere up the hill would be great. Please remedy this".

"Areas need lighting as use after work hours is limited".

You can hardly take a dog anywhere in Kalamunda. So many walk trails all dig [sic] prohibited".

"More fully fenced areas are needed, however there is no need for equipment. People just need safe places to throw a ball and exercise and socialise their dogs".

"more doggy bag locations within the shire footpath locations".

"Double gates. Water in fenced park. Light for night please".

On lead dogs should definitely be allowed on ovals etc and at sporting grounds when no sport is taking place and when sport is taking place if you are there to watch your family. However there is no drinking water supply, other areas are not planned just sparse open spaces with no shade or respite for people walking their dogs. Further is the distinct lack of bins for responsible disposal of faecal waste. These areas are often also unsafe in low light due to use of these areas by unsavoury characters. The safety of pet owners and seeing the opportunity for a shared exercise area for dog and owner should be better considered in the city's value for everything done will make Kalamunda socially, environmentally and economically sustainable.
86	The enclosed areas need to be double gated to ensure dogs can't get out/in when the gates are open. The fencing needs to be to the ground or without big gaps at the bottom. They need to have signs stating the size differences that are allowed in the area.

- I am unaware of any fenced dog exercise areas in Kalamunda too which I'm not sure is down to poor advertising/ signage or if there just isn't any available which is a great shame.
- More appropriate facilities are required in Kalamunda in general, more green, dog off leash areas would be a start.
- Also rangers would frequent Bayswater dog park very routinely and 99% of dog owners would follow the rules due to this, picking up dog waste and being on leash where sign posted, however I've found many dog owners in Kalamunda just don't at all whether that's on public pavements, outside people's houses or in Jorgensen Park which I believe would be better controlled with the presence of rangers.

We have just got a new puppy. The RSPCA hold puppy classes in Gooseberry Hill and Kalamunda Vet also holds puppy classes - but once they are over 3/4 months and the puppies are venturing out into the world there is no opportunity for obedience training (which includes your basic recall which is required at dog parks). Kalapups is commencing offering some training.</p> <p>I believe that dog training (which is also training for the owners) is important for socialized dogs and also enables the dogs to be under effective control.</p> <p>Years ago there was dog obedience offered at Alan Anderson Reserve and then in Gooseberry Hill, but I understand that this training folded due to COVID. I use the Hales dog parks.  
The main issue I have is owners not actually looking after their pets in the parks. I find in the larger dog park in the Hales that the dogs are running around out of site. For most dogs this is completely fine, but for some that a known in the community to cause an issue, it isn't safe for other owners and their pets to be in the area while these dogs are not supervised.  
The other issue I have is that some dogs with poor recall come to the gates to greet new dogs, this is nice but you never know if that other dog is going to run out as soon as you open the gate to let your dog in. Both the large and small park have a cement area inside near the gate, this would be perfect for setting up a double gate to ensure you cannot accidentally let out somebody else's dog.  
My final issue is that throughout the year there is a couple events where prickly plants take over the park. This doesn't last long, but it really causes an issue for dogs with longer hair. My dog included cannot go into the parks during this time of year, as it is too easy for him to get grass seeds and prickles stuck in his ears and feet. A simple weed or overnight spray would eradicate these specific weed species for years to come. As they go un maintained yearly, the infestation is spreading.  
Overall I'm very happy with the facilities at the Hales, I'm just not sure if this region is being upkeep by Satterly or the Kalamunda Council.

Subject: Dog Exercise Management Plan

In addition to the attached survey & my reply as far as the survey allows might I suggest that at all times where there are combined areas where children and leashed or off-leash dog areas, then there must - as a matter of course - be:

1. Signage to parents/carers advising them that THEY have a responsibility to ensure the safety & well-being of their charges at all times.
2. Clear and unequivocal signage for dog handlers that it is THEY who have the ultimate responsibility & charge over the dogs they are exercising.
3. As far as practicable & possible the areas where children may safely play be securely separated from any area where dogs may be permitted or present.
4. If safe areas for children are not practicable then either dogs are banned or the dog exercise area itself be secured, allowing children to play safely.
5. All CoK public rubbish bins should have 'dog refuse bags' attached.
6. If not already in place, then all ranger vehicles should have microchip readers on board & the rangers trained & empowered to use them - without cause - on any & all occasions as a matter of course.
7. Rangers can stop any dog handler [may or may not be the owner/s] at any time & place to verify registration is current & the dog is microchipped; especially where there may be children's play areas.
