4.0 OTHER BUSINESS

4.1 Iris Jones, Lesmurdie

- Q. What is the most up to date report on the Gavour Road, Wattle Grove scheme amendment?
- A. The most up to date report on Wattle Grove is the Draft Local Planning Strategy which was adopted by the Council in September last year. That report was adopted as a confidential report and has been forwarded to the West Australia Planning Commission (WAPC) for their consideration. The WAPC are looking at the report at the present time and will be advising Council very soon on what changes they would like to be made on that report, or whether or not they would accept that the Council proceed to advertising the report for public comment.
- Q. What other plans does Council have in addition to this scheme amendment to ensure our elderly can continue to live in our Shire, given the dire need for Residential and aging in place accommodation emphasised in the Shire's commissioned report of 2006?
- A. The amendment was adopted by the Council and is with the WAPC for their consideration before it is passed on to the Minister to consider the amendment.

- Q. Have any alterations gone to the Minister as yet?
- A. The alterations that we are aware of are only officer to officer comments at this stage. We do not have the official request from the WAPC for any changes to the report that they may want at this stage.

- Q. Can the wording on the Shire Dog Attack Report be altered? Instead of referring to "victim" and "complainant" can an alternative be used as the terminology can be stressful.
