- ii) Every owner or occupier of land to whom a notice is served shall comply with it within the time period specified; and
- iii) Any person who fails to comply with any notice served commits an offence and is liable to action under clause 11.4 of the Scheme."
- b) Duly executes the Amendment documents and forwards them to the Minister for Planning requesting that final approval be granted.

### PS 29 Lot 244 (53) Chisholm Crescent, Kewdale - Warehouse

## PS 31 Shire of Kalamunda Health Local Laws 2001 Review

# COMMITTEE RECOMMENDATION TO COUNCIL PS-31/2010

That Officers amend the draft Control of Animals and Nuisance Local Law 2010 for the Ordinary Council Meeting of 17 May 2010 and provided advice of any consequential impacts on the intent of the Local Law.

# Officers have reviewed the recommended changes and provide the following comments

1. Definition of nuisance – removal of the word 'mental' from paragraph one.

The preference is to retain this word in the definition as it provides for a wider scope of the effect of a nuisance on a person. By removing the word mental may reduce the ability of Officers to assist in resolving some nuisances. Note that this applies to the state of a reasonable person of normal susceptibility

2. Definition of nuisance – removal of the second paragraph

The preference is to retain this paragraph as it provides for a broader scope of a nuisance - it refers to something a person does or permits to be done that **interferes** with or is **likely** to impact on the enjoyment or safe use **of land** by another person (not necessarily their land). Potential to deal with the nuisance before it affects people eg a person burning off resulting in smoke drifting onto a park which may be used later by people while the smoke is present.

The second paragraph is marginally different in that it relates to a person doing something on land that interferes with the enjoyment of land owned by another person. A person who permits sand to drift from their building site to the adjacent property.

The definition of nuisance should be read in context of the actual nuisances listed as per Part 3 clauses 7 -10.

3. Definition of poultry – include the words 'over the age of three (3) months.

Support change.

This would have the effect of allowing a greater number of poultry than permitted under these regulations – however as the basis of these local laws are to prevent nuisance then a higher number of chickens for a short period should not be an issue.

## OFFICER RECOMMENDATION (ORIGINAL)

- 1. Resolves to give state-wide public notice of its intention to amend the Shire of Kalamunda Health Local Laws 2001 and to create the Shire of Kalamunda keeping and Control of Animals and Nuisance Local Law 2010, and invite comment pursuant to Section 3.12 of the Local Government Act 1995.
- 2. Notes in relation to the Shire of Kalamunda Health Local laws that:
  - (1) the purpose is to provide for the regulation control and management of sanitation, housing, waste food, nuisances, lodging houses and offensive trades as part of the function of local governments to provide good governance of persons within its district and in order to enhance the amenity and quality of life of its residents and the community and;
  - (2) the effect is to establish requirements relating to the matters referred to in subsection one on land within the district.
- 3. Notes in relation to the Shire of Kalamunda Keeping and Control of Animals and Nuisance Local Laws that;
  - (1) the purpose is to provide for the regulation, control and management of
    - (i) the keeping of animals;
    - (ii) sand drift, rubbish and litter control on building and construction sites; and
    - (iii) nuisances;
    - part of the Local Governments function to provide good governance of persons within its district and in order to enhance the amenity and quality of life of its citizens and;
  - (2) the effect is to establish requirements relating to the matters referred to in subsection one on land within the district.
