Once you permit has been approved it will only apply to the cats listed in this application. Permit permission is not transferable between cats, if an approved cat is no longer living at the property and you acquire a new cat, a new permit will be required.

All cats over six-months of age listed in this application must be registered with the City of Kalamunda. All Residents are to ensure registrations remain current for the life of the cats listed on the application.

Once the City has received your application along with the prescribed fee payment, surrounding properties will be surveyed. The information collected, along with details contained in your application, will form the basis of our report.

Once a decision has been made by the Manager Community Health and Safety, you will receive written confirmation of the outcome in the form of a advisory letter from the City.

Please complete and sign the attached forms, and return them to the City along with your application lodgment fee of \$195.00.
